ATHLETIC FIELD USE</p> <p>The high school's Track and Outdoor Athletic Complex represents a considerable investment by the taxpayers of the district. It is the desire of the Board to both protect this investment and provide eligible community groups with an opportunity to use the facility. In the interest of preventing misunderstandings concerning the use of the facility the following policy has been adopted.</p> <p><u>Eligibility</u></p> <ol style="list-style-type: none"> <li>1. Group eligibility for the facility shall be the same as those described under the Building Use.</li> <li>2. In no case will a team or individuals not representative of the district be permitted to use the field as their home field for team events or exhibitions.</li> </ol> <p><u>Procedure for Obtaining</u></p> <ol style="list-style-type: none"> <li>1. Write a formal letter of request specifically spelling out your intentions, team rosters, schedules and the name of a person responsible for seeing that members adhere to ground rules, make damage reports to the Superintendent and unlocks and secures the gates.</li> <li>2. Upon approval of the request, the appropriate rent as listed in this policy shall be paid and a key issued to the designated member or individual spelled out in the letter of request.</li> <li>3. Teams using the field for more than one (1) event shall also sign a lease agreement previously approved by the Board and attached to this policy.</li> </ol> <p><u>Ground Rules</u></p> <p><i>Baseball &amp; Soccer:</i></p> <ol style="list-style-type: none"> <li>1. The athletic field may be used for games and for practice at the discretion of the Board, but not to exceed one (1) practice session per week.</li> </ol>

2. Games will be held only on the date set forth in the attached schedule of games.
3. No Sunday games shall begin prior to 1:00 p.m.
4. Teams shall enter and use only the southeastern gate.
5. Team members and spectators will stay off the running track except to retrieve baseballs or soccer balls. In no event shall baseball or soccer spikes be worn on the track.
6. Teams shall furnish their own equipment, including homeplate, pitcher rubber, bases, etc.
7. No alcoholic beverages shall be consumed on the premises.
8. All litter deposited during the course of the use of the field by the lessee shall be removed following each game.
9. All damage to district property and the athletic field shall be reported to the school officials immediately and lessee agrees to pay for any and all damage to the district property occurring during their athletic events.
10. The key to the field will be returned to the school district following the last home game.
11. When playing conditions are questionable, teams shall contact the Athletic Director, Maintenance Chief, or Superintendent.
12. Failure of the lessee to observe and obey any or all conditions of this policy may result in the forfeiture of the privileges granted together with the forfeiture of all rental payments, at the discretion of the Board.

*Track:*

1. School sponsored events such as "Run for Fun" shall have a minimum of one (1) member of the school staff present.
2. Entrance shall be made through the gate adjacent to the gymnasium.
3. Participants shall not use spikes and will use lanes 3, 4, 5 and 6 to prevent overuse of lanes 1 and 2 as prescribed by Resilite Incorporated.
4. No alcoholic beverages shall be permitted on the premises.

5. All litter must be removed at the end of each session.
6. Sessions will end and participants will be off the athletic area by 9:00 p.m.
7. Any damage shall be brought to the attention of school officials immediately.
8. Non-school sponsored track requests shall be handled on an individual basis.
9. No event will be held prior to 1:00 on Sunday afternoon.

Rental

1. Fees for teams using the area as a home field shall pay a designated rental fee per season.
2. Groups using the area for various types of exhibitions shall pay a designated daily rental fee.
3. School sponsored run-for-fun type activities shall be free to participants. All other track activities by groups or organizations shall be handled on an individual basis.
4. Teams using the field for practice shall pay a designated fee per season.
